





- Click on **Payments** and select **US Federal Tax** under **Create Wire Payments**.



### Option 1: Create a US Federal Tax & Interest or Penalty Payment

- Select the **Debit Account Number**
- Select **Tax/Interest/Penalty**
- Enter **Tax Amount**
- Enter **Interest Amount**
- Enter **Penalty (if applicable)**
- Select **Value Date**


